## **WG-I: STATUS OF ACTIONS (PRIOR TO CGMS MEETING)**

This Working Paper presents the status of actions raised in previous CGMS meetings and assigned to WG-I. This WP paper is presented as an input to WG-I aimed to provide all WG-I meeting participants a consistent view on the status of these actions. It is also aimed at facilitating WG-I discussions and dispositions for the relevant actions still to be discussed at working group level.

## WG-I: Status of Actions (prior to CGMS meeting)

### 1 INTRODUCTION

This Working Paper presents the CGMS secretariat view on the status of actions raised in previous CGMS meetings and considered of relevance to be addressed by WG-I.

The actions raised in previous CGMS meetings are maintained by the CGMS secretariat in a centralised database. Status of actions is reviewed at plenary level at the beginning and end of the CGMS meetings with inputs provided by the discussions in the different working groups. Therefore, it is considered “good practice” to report to WG-I, prior to the meeting, on the status of actions relevant to the activities of this working group for facilitating focused discussions and allowing adequate and timely conclusions at the end of the working group meeting in order to provide consolidated status of actions for the final discussions at plenary level.

### 2 Actions status of WG-I at the time of preparing CGMS 39 meeting.

The extract from the action database maintained by CGMS secretariat with the actions assigned to WG-I is provided in Annex I. From the extracted list of actions from Annex I, status is as follows:

**Action 38.15:** CGMS Members to provide to each CGMS meeting a list of frequencies used by their current and future systems in the format provided in WG I report (Annex 1) (merged version of WMO frequency reports amended with the extra fields as provided in Tables 1 and 2 of Document CGMS-38 EUM-WP-23).

**Deadline:** CGMS-39

**Status:** Considered to be a “permanent” actions in WG-I and aimed to have corresponding WPs provided by CGMS members for each one of the CGMS meetings.

**Action 38.16:** CGMS members to provide to the CGMS Secretariat and IMD their operational and planned use of the data collection service (regional and international) that contains or overlap the band 402.25-402.65 in a format as provided in Annex 1 of this WG I report.

**Deadline:** 15 December 2010 at the latest.

**Status:** Answered. Inputs provided by JMA (15/10/2010), NOAA (15/12/201) and EUMETSAT (at CGMS 38 meeting). Reminder sent by CGMS Secretariat to all CGMS members on 14/01/2011. No additional replies provided.

Propose to formally close this action at CGMS 39 meeting.

**Action 38.17:** Concerning US public enquire for sharing with 4G mobile systems of the 1675-1710 MHz band CGMS members are encouraged to provide CGMS secretariat their inputs and position regarding the impact on their current and future systems (or a more general copy of the letters submitted in response of the US public enquire).

**Deadline:** 1 December 2010.

**Status:** Closed. See CGMS Secretariat mail on 26 January 2011.

**Action 38.18:** CGMS Secretariat to draft a letter to the appropriate US officials to address the concern of the WMO and CGMS members and the implications on their systems and services based on the shared use of this band by 4G mobile systems.

**Deadline:** 15 December 2010.

**Status:** Closed. See CGMS Secretariat mail on 05 January 2011.
